- Identity document/smart ID card (if you are a South African citizen)\*\*\*
- · Valid passport (with no less than six (6) months to expiry) (if you are not a South African citizen)
- Proof of residential address\*

# Representative (if applicable)

- Identity document/smart ID card (if you are a South African citizen)\*\*\*
- Valid passport (with no less than six (6) months to expiry) (if you are not a South African citizen)
- · Proof of authority to represent the investor (no proof for the parent of a minor)
- · Proof of residential address

### We will accept the following as proof of residential address (not older than three (3) months):

- A bank stamped or estamp (electronic) bank statement
- Utility bill
- · Current lease or rental agreements (less than one (1) year)
- · Municipal rates and taxes invoice
- Mortgage statement
- Current tax return
- Valid motor vehicle license current year
- Correspondence from a body corporate or share-block associate Letter to be on the letterhead of the corporate body of share-block associate
- FICA declaration form
- Expatriate declaration Letter to be on company letterhead from the employer confirming employment, contract period (if not permanent) and address and should be accompanied by a valid residency and/or work visa
- Short-term insurance policy document/contract or Letter Must be on the letterhead of the insurance company and Financial Services
  Provider (FSP) number must be visible/recorded on the document and must confirm the existence of the policy
- Official employer letter For employees residing on company premises
- Official University/technikon/college or tertiary institution registration letter on the letterhead of the institution

## If you do not have proof of residential address in your name, we will accept the following from your co-habitant:

- · Co-habitant address form (joint address form) accompanied by utility bill
- · Affidavit (Any Commissioner of Oath)

<sup>\*\*\*</sup> If you are a South African citizen and your Identity Document/Smart ID card is not available, attach a certified copy of a valid passport (with no less than six (6) months to expiry) **AND** valid reason why an Identity Document/Smart ID could not be provided. Smart ID to be scanned on both sides.
